- vii. Advice the Project Management Team on stakeholder engagement and capacity development areas.
- 3. The tenure of the Committee will expire with the NMHS.
- 4. The Committee shall meet as frequently as the members may decide.
- 5. The Committee would be free to co-opt any additional expert members as per requirement to provide guidance on specific issues with the approval of the Chair.
- 6. The non-official members of the Committee shall be entitled for travelling and all other allowances as applicable, as per GoI rules.
